- e) Written declaration on the fact that the product to be authorised or any of its properties and name do not breach the personal property right of third person
- f) If the manufacturer is not the same as the applicant, the manufacturer's mandate for the authorisation
- g) If the manufacturer is not the same as the authorisation holder declaration showing the name of authorisation holder
- h) Consent given by the owners of protected trade names, commercial names
- i) Certification by the manufacturers of the basic materials used for the production of the formulations confirming that they approve to use the basic materials in the formulation and assure its provision for at least 1 year
- j) If wastes are processed, permit for waste treatment
- k) If by-products of animal origin are processed, permit by the animal health authority
- l) Permit issued for the premises
- m) Person or company, who undertakes the expenses (name, address, VAT number, postal address)
- n) copy of permit for experimental use
